GUIDELINES FOR THE CLARK GALLERY

2023 92 County Art Show

January 5 – February 12, 2023

Welcome to the Clark Gallery 92 County Art Show! This competition is just one way that the Clark Gallery supports the visual arts. The Clark Gallery hosts several exhibits per year and features students, amateurs, and professionals. Because the Gallery encompasses the semi-circle of the Honeywell Center Porter Lobby, foot traffic exceeds 170,000 guests per year!

Honeywell Arts & Entertainment encompasses the full range of arts opportunities and venues of The Honeywell Foundation, a nonprofit public arts charity in Wabash, Indiana. The organization is dedicated to providing arts, education, and entertainment opportunities for all. Offerings take place at six venues: the Honeywell Center, Honeywell House, Eagles Theatre, Charley Creek Gardens, Dr. James Ford Historic Home, and the 13-24 Drive In. Programs are made possible by the Indiana Arts Commission and the National Endowment for the Arts: a federal agency, and by generous donors.

ABOUT THE COMPETITION:

This competition is open to artists residing in all 92 counties in the State of Indiana!

Guidelines are listed below:

- An artist may enter up to **three** pieces. (Collaborative pieces by more than one artist may be submitted. The “collaborative team” will need to be considered one artist on the entry form. Individuals from the collaborative team may also pay a separate entry fee for solo submissions.)
- There are three categories: Painting, Drawing, and Other Art Forms. An artist can enter into all categories, but the maximum of three entries total still applies.
- The Other Art Forms category is for any medium that does not fit into the Drawing or Painting category (except for photography which does not qualify for this competition).
- The Drawing category makes use of any number of drawing instruments. Common instruments include graphite pencils, pen and ink, inked brushes, wax color pencils, crayons, charcoals, chalk, pastels, markers, stylus, or various metals like silverpoint.
- Pastel artists who fill the surface as a painter are allowed to display in the painting category.
- **Each wall-hung entry must have a frame and a hanger.** The only exception is “gallery-wrapped” canvas. If these canvases are unframed, the image must bleed over the edges and no staples can be exposed. The best hanging device is a wire strung between two metal eyehooks. A saw tooth hanger is acceptable, but not recommended. Honeywell Arts & Entertainment is not responsible for damage to artwork due to hanging device failure.
- The competition is open to participants of all ages.
- Amateur and professionals, including students are allowed to enter.
- It is the artist’s responsibility to obtain a model release from recognizable subjects in portraits and provide the release upon request.

- **Work previously accepted into a Honeywell Arts & Entertainment competition may not be re-entered.** Any pieces entered but not accepted in past competitions may be entered again. Honeywell Arts & Entertainment competitions are the 92 County Art Show, Themed Art Competition, and Photography Show.
- Employees and immediate family members of The Honeywell Foundation, Inc. are able to participate. Please note that you must mark the box on the entry form and pay the entry fee. You will be ineligible to receive cash prizes, but can still win award placings/ribbons. Your artwork can be listed for sale.
- The Clark Gallery is a public space. The subject matter of entries needs to be appropriate for all ages.
- Honeywell Arts & Entertainment is not responsible for damage to artwork during the judging, display, or storage periods.
- Honeywell Arts & Entertainment may reproduce artwork for promotional and archival reasons.
- **There is no size limit**, but the entry must be able to be displayed within the capabilities of the Clark Gallery.
- Prints of an original cannot be entered (including giclées); **only the original artwork will be allowed.**
- Photography may not be entered. (This is not meant to discredit the art form of photography. It is because we host a photography competition every fall.)

RECEIVING:

Artists (or his/her agent) must deliver artwork to the Honeywell Center during the following periods: **January 3, 2023 11 am to noon or 5 to 7 pm**

Enter through the automatic doors at the Circle Drive Entrance on the corner of Carroll and Market Streets. The Honeywell Center is located in downtown Wabash at 275 West Market Street, Wabash, IN 46992.

ENTRY FORM, FEE, AND LABELS:

Please complete and bring the attached entry form to the Center when you deliver the artwork, along with payment. Methods of payment include cash and check. Checks should be made payable to Honeywell Arts & Entertainment. The entry fee is \$20 regardless of the number of pieces submitted. No refunds will be made if entries are not selected. Please complete the labels clearly and attach them securely to the back of each entry in the **lower left hand corner**.

JUDGING:

The show will be judged after 7:00 pm on January 3. The judge(s) will decide which entries will be accepted for display. Honeywell Arts & Entertainment has the right to refuse to display an entry based on content. For example, nudity is not allowed. However, Honeywell Arts & Entertainment plays no role in the actual judging process. **The names of the jurors are not released in advance to protect the integrity of the show.**

A common question is, "What do the judges look for?" As you can imagine, this is a difficult question to answer. Each juror has personal preferences and juried shows are always subjective. In general, most judges look for items that include: interest, composition, ways to increase impact, ideas for different techniques, how to better communicate a message, and presentation.

DISPLAY:

The show will be on display in the gallery from January 5 through February 12. The Clark Gallery is open to the public Monday - Friday 8 am to 5 pm. Artwork may be purchased by calling the

box office during those hours 260.563.1102. The Center is closed on all major holidays. Work accepted in the show may not be removed before February 13 without permission from the Director of Arts. At times, events in the lobby may limit access to the Clark Gallery.

NOTIFICATION:

All artists will receive a list of accepted entries via email on January 4, no later than noon. The catalog of the entries accepted and the winners will be posted for public notification on our website www.honeywellarts.org on January 5.

CATEGORIES AND PRIZES:

COMMISSION:

Honeywell Arts & Entertainment charges a twenty (20) percent commission on work sold at the Center. Checks from Honeywell Arts & Entertainment will be mailed to the artists at the end of the show, less the commission percentage. Please allow 5-10 business days after the close of the show to receive checks. Purchased pieces must remain in the exhibit through the end of the exhibit.

PICK UP:

If you had pieces that were not accepted AND accepted into the show, you may pick it all up when you retrieve your accepted pieces.

Pieces Not Accepted: Artists (or his/her agent) may retrieve these works on **January 5 between 11 am and noon or 5 and 7 pm.** Everyone must complete the **sign out portion of the entry form** (available at the pick-up location) before removing any artwork.

Pieces Accepted: Work accepted for the show must be picked up by artists (or his/her agent) on **February 13 from 11 am – noon or 5 – 7pm in the gallery. If you are unable to pick up your entries, please call or email the Director of Arts to make special arrangements for pick up.** Everyone must complete the **sign out portion of the entry** before removing any artwork.

All artwork not retrieved by 5 pm on April 13 will become the property of Honeywell Arts & Entertainment, unless the Director of Arts approves an extension.

TIMELINE:

January 3 – Drop off artwork between 11 am – noon or 5 pm – 7 pm

January 4 – Accepted pieces announced by noon

January 5 – Pick up unaccepted pieces between 11 am – noon or 5 pm – 7 pm

January 5 – Exhibit opens to the public

February 12 – Last day of exhibit

February 13 – Pick up all pieces 11 am – noon or 5 pm – 7 pm
